## **Community Education Council District 28**

Resolution Opposing District 2/Manhattan High School Admissions Priority

**WHEREAS**, on May 2, 2024 New York City Public Schools (NYCPS) Chancellor David C. Banks announced that he would reinstate "some kind of priority" for students in District 2 in high school admissions.<sup>123</sup>

**WHEREAS**, the NYCPS Office of District Planning reported in its Fall 2023 Manhattan High School Data Summary Report that, in respect of Manhattan, "there is an excess of high school seats in all districts, particularly in District 2."<sup>4</sup>

**WHEREAS,** with a total high school enrollment of 32,471 students and total capacity of 41,922 seats, District 2 has an excess high school capacity of 9,451 seats, more than any other community school district in the NYCPS system.<sup>5</sup>

**WHEREAS**, the Office of District Planning reported in its Fall 2023 Queens High School Data Summary Report that Queens has a deficit of 863 high school seats.<sup>6</sup>

**WHEREAS**, the Office of District Planning has reported that District 28 alone has a deficit of 426 high school seats, while neighboring District 25 has a deficit of 1,099 high school seats, and District 26 has a deficit of 2,351 high school seats.<sup>7</sup>

**WHEREAS**, the Office of District Planning has warned that Districts 25, 26, and 28 are "serving more students than the buildings have capacity for. Schools in these buildings may experience high demand and overcrowding, and therefore maybe programming creatively to accommodate students." <sup>8</sup>

**WHEREAS**, the number of excess high school seats in District 2 is more than adequate to cover the entire deficit of high school seats in Queens, and continued access to those seats by out of district students eases pressure on overcrowding in adjacent and nearby districts, including those in Queens.

**WHEREAS**, any reinstatement of district priority in high school admissions for students in District 2 or implementation of borough priority for students in Manhattan would result in fewer choices of high school opportunities for students in District 28 and elsewhere in Queens.

**THEREFORE, BE IT RESOLVED,** that the District 28 Community Education Council urges Chancellor Banks to reconsider his stated intent to grant geographic priority in high school admissions to students in District 2 or to students in Manhattan until the Office of Student Enrollment and the Office of District Planning can provide a detailed analysis of the impact of those changes in admissions priorities on high school admissions citywide.
